- ❖ Both parents are U.S. citizens prior to the birth of the child and birth was in wedlock: Select **Requirement B**
- ❖ Both parents are U.S. citizens prior to the birth of the child and birth was out-of-wedlock: Select **Requirement C**
- ❖ Mother is transmitting citizenship and child was born out of wedlock: Select **Requirement C**
- ❖ Father is transmitting citizenship and child was born out of wedlock: Select **Requirement A** (Page 3 of DS-2029 needs to be filled out or DS-5507 needs to be submitted. Marriage evidence is not applicable)

**Please Note: You are required to submit all original documents on the checklist. However, if you are unable to submit your original traveling documents (e.g. Passports), we will accept legible copies of all the pages as long as the originals are submitted during the interview.
